Dr. David Nersessian is an Assistant Professor in the Accounting and Law Division of Babson College, where he teaches Business Law to undergraduate and MBA students and an elective in Public International Law. He earned his D Phil (PhD) in Law from Oxford University, where his research concentrated in public international law and human rights. He earned his JD *magna cum laude* from Boston University School of Law and his BSBA *summa cum laude* from Boston University School of Management. Prof. Nersessian serves as the faculty lead for Babson's PRME (UN Principles on Responsible Management Education) initiatives and also as the college's pre-law student advisor.

Prior to completing his doctoral work, Dr. Nersessian practiced for six years with several large law firms, representing clients in complex commercial litigation in state and federal courts, administrative proceedings, and private arbitrations throughout the United States. He later spent five years as the vice president and general counsel of an international educational nonprofit.

Before joining Babson, Professor Nersessian spent many years at Boston University in a variety of roles. He was Assistant Dean of Global Programs and a Senior Lecturer at the Questrom School of Business and both a Visiting Assistant Professor and Lecturer at BU's School of Law. He also served as the founding Executive Director of Questrom's Susilo Institute for Ethics in a Global Economy. Prior to joining BU, he was Executive Director of Harvard Law School's Center on the Legal Profession and a Supreme Court Fellow at the US Supreme Court, where he worked for the Chief Justice's chief of staff. Before that he taught Criminal Law for St. Edmund Hall and St. Benet's Hall at Oxford University.

Dr. Nersessian's research concentrates on public international law, human rights, legal ethics, globalization, and the management of legal and ethical risk in the corporate setting. He has a particular focus on the role of corporate lawyers in human rights issues and the impact of globalization on the ethical regulation of attorneys. In addition to his work in globalization and ethics, he continues to write, speak and consult in public international law and human rights. He also has taught international law subjects to federal judges on behalf of the Federal Judicial Center.

Dr. Nersessian's book *Genocide and Political Groups* was published by Oxford University Press in 2010. His second book, *International Human Rights Litigation: A Guide for Federal Judges* appeared in print in early 2017. This book, which is a scholarly monograph on the Alien Tort Statute and related topics, was commissioned by the Federal Judicial Center to educate ~1,400 federal judges and magistrates nationwide on how to effectively hear and resolve human rights cases on their dockets.

Professor Nersessian's current journal scholarship analyzes: (i) the intersection of "big data" analytics and human rights, and (ii) the governance implications and ethical risks for corporate lawyers arising out of legal work that facilitates human rights violations abroad. His most recent paper, *Beyond Privacy: Rethinking Big Data Analytics and International Human Rights*, received the Academy of Legal Studies in Business Virginia Maurer Outstanding Ethics Paper Award in 2016. Dr. Nersessian also is working with a major global hotel chain on a case study about the hospitality industry's efforts to combat human trafficking.
